Summary Ministry Description:

What we value about living in our area:

Avon Lake is a sought-after residential community that takes full advantage of its Lake Erie northern border. Multiple points of access to Lake Erie provide easy opportunities for recreation and leisure, as do numerous inland parks and hiking/biking trails. While the city originally was a favored location for lakeshore summer homes, it has grown into a high quality, family friendly suburb. Quiet neighborhoods have easy access to employment, shopping, medical, sports, dining, and business centers. Avon Lake schools are consistently ranked high for academics and extracurricular achievements. The tax base is considerably lower than neighboring communities in Cuyahoga County, and homes typically hold and increase their value over time.

1b. SCOPE OF WORK

Full time Pastoral Position 40-50 hours weekly

Worship and Spiritual Nurture / Faith Formation

- Prepare and lead Sunday worship including scripture study, liturgy and prayer crafting, sermon
 preparation, lay liturgists recruiting and guiding, media and music planning with staff and
 volunteers.
- Identify and coordinate activities for congregational faith formation and development through prayer groups, Bible studies, special event programming, service opportunities, and other activities.
- Plan and officiate weddings, funerals, and memorial services for members of the congregation, including services held in Avon Lake UCC's Memorial Garden.
- Increase personal faith and improve skills for ministry and worship through personal and professional study and prayerful reflection.

Pastoral Care and Wider Community

- Provide Pastoral care in collaboration with lay staff and volunteers, including counseling, listening, referral to outside services, and visitation of the hospitalized and homebound.
- Create and promote cross-generational opportunities for connection, fellowship, and relationship-building, with careful attention to welcoming new members.
- Lead the Church to be an ambassador of God's love to the wider community for funerals, weddings, special events, and worship programs; be a representative of the Church to local organizations.

Administration and Vision / Head of Staff

- Plan strategically for current and new directions in ministry.
- Steward financial development and Church resources faithfully and openly. Be transparent and forthcoming about giving needs and financial status to the congregation.
- Attend meetings and provide advice and counsel as needed for Church programs, in collaboration
 with lay leadership and volunteers. Attend monthly Church Council meetings and work with the
 Moderator and various Team Leaders as opportunities and issues arise.
- Participate in wider Church activities such as conference and association meetings.
- Provide leadership development opportunities for the Church staff and lay leadership to meet identified needs of the Church.
- Supervise staff including assisting with annual personnel reviews for staff and addressing personnel issues that may arise.
- Supervise lay leadership as representatives of Church business and reputation in the community.

Core Competencies:

The Avon Lake UCC seeks a Senior Minister who can provide the following core skills:

Impactful and Inspiring Communication – Someone who is capable of relating biblical teachings to current daily life and who ignites a passion for helping others.

Innovative Leadership – A leader who is willing to offer different types of worship experiences, new ideas for mission, creative programming, and positive change while maintaining sacred stories and traditions.

Interpersonal Proficiency – A person with the ability to match interests and talents of the congregation with needs of the Church related to identifying lay leaders, connecting new members with existing members in fellowship, and encouraging participation in existing and new mission projects.

Administrative Competency – Someone with experience and a positive track record for staff management and development, financial oversight, and anticipating and planning for future needs of the Church and its members.

Self-Care Awareness – A person who prioritizes taking care of oneself and the Church staff spiritually, emotionally, mentally, and physically to avoid burnout and remain a vital force in our congregation.

Conflict Management Ability – A clear and open listener with the ability to navigate challenging conversations and craft solid solutions.

2. WHO IS GOD CALLING US TO BECOME?

"You shall love the Lord your God with all your heart, and with all your soul, and with all your mind."

Who is God calling you to become as a congregation?

The members and leadership of Avon Lake UCC believe God is calling us to continue being a loving and kind congregation that welcomes everyone regardless of where they are on life's journey. We are called to listen for God's direction through scripture, sacrament, and community. We are also called to make connections, develop friendships, and build a firm foundation for a lifetime journey of faith. As a congregation, we are encouraged to explore questions of faith and life; cultivate a commitment to service; grow individually and in community; and to walk in the ways that Jesus modeled for us, showing justice and compassion. We are called to participate in the life and mission of this community, sharing regularly in the worship of God and enlisting in the work of this congregation as it serves the community and the world.

Describe how God is calling you to reach out to address the emerging challenges and opportunities of your community and congregation.

Below are three areas that stand out as challenges Avon Lake UCC has addressed and continues to improve upon which provide the opportunity to grow and change.

MISSION:

The mission statement of the Avon Lake UCC is Growing People to Serve God and Others. As part of that guiding purpose, the heart and soul of Avon Lake UCC is its commitment to outreach and mission. We are a strong and faithful congregation that sees the needs of our members and our community and grows to meet those needs. We are proud to own and operate a nonprofit resale shop called the Good Neighbor Thrift Shop. All proceeds from the Thrift Shop go toward the needs of the Mission Partners we support all year long. Our mission giving provides resources for youth mission trips and valuable assistance to organizations throughout our community and beyond. With the help of volunteers and donations, we are able to regularly provide meals to shelters for homeless individuals and families and survivors of domestic violence; help stock our local food bank and Community Resource Center; support individuals in addiction recovery; and provide financial support to families in need. When unexpected needs arise, our congregation finds a way to expand our mission outreach to provide additional support. For example, our Church helped prepare a home on Cleveland's West Side for the resettlement of a family from Afghanistan and seven of their children. A group of volunteers from the congregation came together to assist the family members in multiple ways including applying for their documents, driving them to doctors' appointments, stores, and other errands, and helping them build a support system in the local community. We also extended our help and support by setting up an apartment for a displaced Ukrainian family. The Church recognizes the immediate needs of both Church members and the local community and steps in quickly to provide assistance.

YOUTH PROGRAMMING:

Avon Lake UCC recognizes the importance of our youth for the future of our Church and our community and is proud to be a leader in youth programming for children of all ages. Beginning with Sunday school programming and including youth programs for elementary, middle, and high school students, we believe in introducing children into Christian living and providing our young people with an environment where they feel accepted, welcomed, and understand the scope of God's endless love. When a student is in their 8th grade year, we offer our Confirmation program as an opportunity for them to learn about what Church membership is all about and the ways of living out our Christian beliefs as an adult. With our senior high students, we provide an opportunity to worship God, study God's word, and discuss God's hope for our lives in an open and accepting environment. Our Youth Ministry program not only develops relationships, but also develops youth leaders. Each fall we invite our high school students to apply to be a part of a Student Leadership Team. This group of young people is instrumental in planning, developing, and leading our Sr. High Youth Group, providing feedback, offering ideas, and assisting with so much of what we do throughout the year.

Over the years, our youth programming quickly grew and so did the need to provide a dedicated space. We converted our unused parsonage to create a space for youth activities and called it The Buoy. Having a dedicated space like this for youth activities directly signals the value we put on our young people and our care for them. All of our youth activities are open not only to members of our Church but to any youth in the surrounding community. The Buoy is a diverse, inclusive, accepting, welcoming, and safe space for any young person, no matter who they are or what they believe or who they love...as they navigate the choppy waters of adolescence.









WORSHIP STYLE CHANGE:

For many years, Avon Lake UCC had two Sunday services (9am and 11am) that were traditional in nature. Over the years, members of the congregation were asking for an option of a contemporary worship format. Our initial effort was to create an informal service on Sunday evenings, but that time slot was not good for many of our members. One of our consistent values is to grow the congregation and provide worship experiences that speak to everyone. Through extensive research, consultation, and prayerful discernment, our Senior Minister and Church Council took steps to create one service specifically designed with this need in mind. While our 9 am service continues to have traditional music with a choir and a traditional presentation of the liturgy from the New Revised Standard Version Bible, the 11 am service now incorporates more video technology, a contemporary worship band, and readings from a variety of versions of the Bible. Providing two formats meets the diverse needs of our congregation. The contemporary service has brought in many new members, including many young families, and is very well attended. The traditional service is also well attended and continues to meet the spiritual needs of many long-term (and new) members. Having an option for both forms of worship has provided our Church with the opportunity to continue to be a special place for a diverse congregation.

3a. CONGREGATIONAL REFLECTIONS

Describe your congregation's life of faith.

The Avon Lake UCC is the first congregation established in Avon Lake, Ohio. Our mission is Growing People to Serve God and Others. Our members come from Avon Lake and many surrounding communities. We are individuals and families, of all ages, from a variety of church backgrounds (or none). We are an open and affirming community of Christian people committed to the acceptance of ALL people and respecting individual beliefs and perspectives is part of our inclusive nature. Our Church members describe us as "a family of Christian people where everyone has an opportunity to grow in their spirituality and faith in a loving and safe environment." We are here to learn from each other how to live as followers of Jesus in our time and place.

Describe several strengths or positive qualities of your congregation.

We are a Church known for its extravagant warm welcome to all people, regardless of where they are on their faith journey. Avon Lake UCC is proud to be considered a "Big Tent Church" where Christian people who hold a diversity of viewpoints are united in Christ. We do not all share the same political opinions. We celebrate and embrace diversity and encourage cultural sensitivity and civil discourse. We are a Church that believes that as Christians we should share God's passion for justice, and we pray for justice in both local and global issues.

We are also a Church with extensive Care Ministries. For decades, the Stephen Ministry program has provided supportive care for people in life crises of all kinds. We currently have a large active group of Stephen Ministers and Leaders who are all engaged with care receivers at this time. In addition, the Parish Nurse program, under the direction of our Parish Nurse and numerous volunteers, provides regular support, encouragement, and resources through several groups: grief support, caregiver support, and mental health support, Doorstep Dinners, Heavenly Helpers, and hosting the Life Memory Cafe, a new dementia-friendly program. Life happens . . . we care, God cures.

We have a strong Christian principle of providing service to Avon Lake, surrounding communities, and those across the region through our mission focused programming and opportunities to make a difference for good in the world. Avon Lake UCC is committed to the stewardship of the gifts entrusted to us and sharing with those less fortunate. We continue to be a Church where everyone's time, talent, and treasure are encouraged and utilized. We are proud to own and operate a nonprofit resale shop called the Good Neighbor Thrift Shop. All proceeds from the Thrift Shop go towards the Mission Partners we support all year long. Thanks to the phenomenal success of the Good Neighbor Thrift Shop we are able to disburse substantial funds in year-end giving each year!

We have an impressive youth program that helps young people develop strong Christian principles of service and love for others. This remarkable ministry focuses on relationships and worshiping God while helping our youth navigate the complicated and confusing challenges they face every day. During the year, the youth participate in fellowship activities and service projects with students from other churches in the Cleveland area. What once served as the Church parsonage was converted into an incredible dedicated space, called The Buoy, solely for our youth programming.

We have a rich and diverse music ministry program that is growing and consists of both vocal and instrumental music that features a Worship Band, a Chancel Choir, and a Bell Choir. Our music ministry extends past the Sunday service and includes community programming from individual concerts featuring local talent, to full ensembles including the Grammy-winning baroque orchestra Apollo's Fire, the Cleveland Pops Chorus, and the Cleveland Orchestra.



Describe what worship is like when your congregation gathers.

Avon Lake UCC provides a variety of meaningful worship experiences both in person and online that are prayerfully and thoughtfully planned. We offer both traditional and contemporary styles of worship that are designed to inspire and feed the soul. Sermons are impactful, relevant, relatable, and preach the Word of God as it relates to everyday challenges.

Both services include the use of video projections and technology to support themes woven into the worship order. The Sanctuary has projectors used during worship at the front and back of the room. The Sanctuary also has four ceiling-mounted cameras so worship services can be live streamed via Facebook, as well as shared live on Avon Lake Community Television, with repeats daily. Recordings of every service (plus any videos we make) are shared in HD at https://vimeo.com/avonlakeucc

We explore musical worship through a wide variety of genres and styles. The traditional service typically is accompanied by piano, organ, and choir. Our contemporary service provides a worship experience that includes the use of drums, guitars, and electronic keyboard.

A Children's Moment is provided at the 11 am service and helps introduce the biblical theme that will be taught during Sunday school and is tied to the sermon message as well. Sunday school is offered year-round every Sunday during both services. We are pleased to be able to accommodate children with special needs.

Describe the educational program/faith formation vision of your church.

We are proud to provide faith and spiritual growth programming for all ages throughout the year. Our Church is known in the community as an active Church. Through our adult education and Bible study programs, children's ministry, vacation bible school (VBS), Cross Training (twice yearly adult education programming), Music Ministry, and Youth Programming there are fellowship opportunities for everyone. All of our programming is open to any member of the community who wishes to participate, whether or not they are members of the Church.

Avon Lake UCC is a strong leader within the community of Avon Lake and Lorain County. We are a leader in faith ministry, youth programming, mission engagement, mental health support, Stephen Ministry, and caregiving support. We are a faithful congregation that sees the needs and grows to meet those needs. Avon Lake UCC serves as an anchor of support and provides an environment of respect and love. Our Church was built on a strong foundation and continues to be a beacon of light in the darkness for those who need it.

Describe how your congregation is organized for ministry and mission.

When it comes to decision-making, how many hours are spent in meetings per month?

The work of the Church is broken down into various Teams that attend to specific areas of decision making. The current Church Bylaws identify the following Teams: Family Faith Formation, Worship, Membership, Mission, Finance, Trustees, Thrift Shop, and Youth Ministry. Each Team meets once a month to discuss the work or projects within its responsibility. The leader of each Team also attends the monthly Church Council meeting to report on activities and concerns. The Senior Minister attends Team meetings as desired but is not expected to attend the Team meetings on a regular basis. The Senior Minister is expected to attend the Church Council meetings and is also available to Team members for any advice or counsel required for the Team to perform their work. Most Team meetings last between 1-2 hours, with some variation depending on the focus of the Team and the time of year or specific activities/projects.

Think of a time when action had to be taken quickly, for example when a crisis or disaster occurred. How was that accomplished?

Thankfully we have not had any crisis or disaster incidents, however, in 2015 we watched as tragedy occurred with a shooting at a place of worship in a different community and immediately took steps to create a Safety Committee. In the process, we developed a robust documented Safety Policy and Procedure Plan in the event of an act of violence or natural disaster. Training is provided by law enforcement to the Safety Team members who now patrol the Church building and grounds during worship and other events. We conduct an annual evacuation drill with the congregation each year as a safety measure.

REFLECTION

After reviewing the congregational demographics and activities above, what does this information reflect about your congregation's overall ministry?

Avon Lake UCC provides a spiritual home for citizens of Avon Lake and surrounding communities. Our Church is known for being welcoming to individuals and families at various stages of their faith journey. Avon Lake and the surrounding communities are not racially or ethnically diverse however, as reflected in our Statement of Welcome and Inclusion, we encourage and invite all people of the community (members or nonmembers) to join us in worship, educational, and fellowship activities. Our Church does reflect diversity in age, gender, gender identity, sexual orientation, socioeconomic status, and political perspectives. The Church extends itself to the wider community through mission projects locally, throughout the state of Ohio, and in other parts of the United States. Our youth program is widely respected in our community and in the mission locations we travel to each summer. Within our congregation, we provide spiritual support and fellowship programs through regular worship, the Stephen Ministers, Parish Nurse, small group activities, large group meals and events, and special music events. Our Church is supportive of local community groups, providing space for AA meetings, providing meals and financial assistance to area homeless shelters, domestic violence shelters, addiction recovery homes, and our sister church in Cleveland. Avon Lake UCC is a vibrant active church working daily to meet the spiritual and personal needs of our members and our community and to live our mission of Growing People to Serve God and Others.

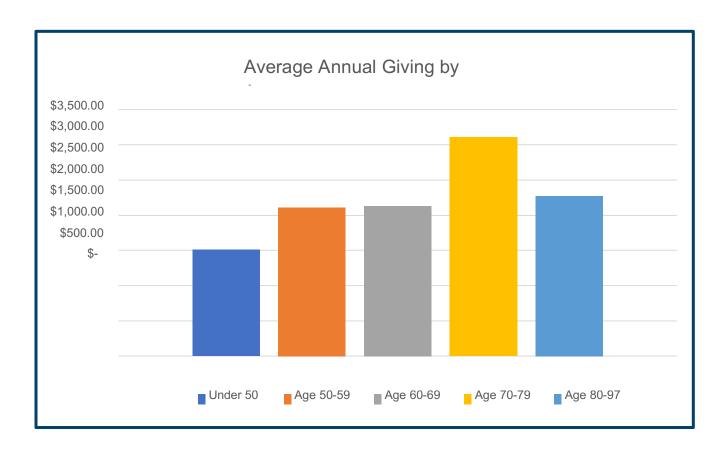

NOTE about the Thrift Shop: Avon Lake UCC is unique in that, as part of its ministry and mission, it operates a thrift shop in Avon Lake, Ohio called the Good Neighbor Thrift Shop (the "Thrift Shop"). Until recently (2020), the Thrift Shop's financials were kept separate from the broader Church's; however, they are now incorporated into Avon Lake UCC's balance sheet and statement of activities.

The Thrift Shop's revenue has traditionally been used to cover its operating expenses and to support mission partners, including the UCC's Our Church's Wider Mission (OCWM) fund. The Thrift Shop was started over 40 years ago as a way to help the Church meet its obligation to support OCWM; in the past several years its revenues have increased significantly. The broader Church's funds are not used to cover Thrift Shop expenses. Awards to local mission partners are reviewed by the Team that oversees the Thrift Shop and receive final approval from Church Council. Historically, there has been significant push back against using Thrift Shop funds to support the Church's General Fund or capital projects as the Thrift Shop was created to provide mission support. This was most recently discussed by the Church Finance Team in 2022, and it was decided to maintain the status quo. Thrift Shop proceeds are used, rarely upon request, to support specific mission activities of the Church (typically youth programming). The use of Thrift Shop funds for the Church's general expenses was most recently

discussed by the Church Finance Team in 2022, when it was ultimately determined to keep the status quo.

Attached are (i) Avon Lake UCC's Balance Sheet as of December 31, 2023, and (ii) Statement of Activities for the period from January 1, 2023, through December 31, 2023, and the 2024 Annual Budget. These materials include the Church and Thrift Shop on a combined basis.

Avon Lake UCC pays OCWM (Basic Support) from the Thrift Shop's proceeds. It contributes \$4,000 per month or \$48,000 annually.

What is the church's current indebtedness?

Avon Lake UCC has two forms of indebtedness: (i) a mortgage, with Huntington National Bank in the amount of \$426,020.61 as of the date of this Church Profile (the "Mortgage"); and (ii) 4 credit card accounts.

The Mortgage consists of monthly principal and interest payments of \$5,789.87. In addition, the Church typically makes an additional principal payment of \$1,314.13. The Mortgage matures on February 5, 2026, at which time a balloon payment will be due. The current interest rate is 3.99%. If the Church continues the above payment schedule, the anticipated balloon payment will be \$281,000.

The Church uses the credit card accounts to cover certain monthly expenses. All credit card accounts are paid in full each month and the Church does not carry an interest-bearing balance.

Total amount of loan debt: \$426,020.61

Reason for debt: Outstanding loan balance for funds used to build the current Sanctuary.

Are capital and other payments current? Yes

If a building program is projected or underway, describe it, including the projected start/end date of the building project and the total project budget.

Church staff and members regularly review and assess the Church's and Thrift Shop's buildings and grounds. During the COVID-19 pandemic while in-person activities were not held, the Church conducted a number of large renovation projects, including maintenance on the Sanctuary, a complete renovation of the Education Wing, and the installation of its Courtyard Cafe. While there is no material building program currently underway, below are examples of projects the Church is currently conducting.

In addition, the Church would like to renovate its music room and remodel its existing restrooms when funds become available.

If the church has had capital campaigns in the last ten years, describe:

There have been no capital campaigns in the last ten years.

If a capital campaign is underway or anticipated, describe:

The Church formed a committee in 2019 to begin planning for a capital campaign. The COVID-19 pandemic ended those conversations. Those conversations likely would have been restarted if the Church's Senior Minister had not been planning her retirement. She believed that it was best not to start a campaign near the time that her retirement was announced. The capital campaign goals were not solidified, but the conversations focused on renovating the oldest bathrooms, converting them to single-person, gender-neutral, family friendly restrooms. Other projects discussed included kitchen renovation, music room renovation, and mortgage reduction.

Describe the prominent mission component(s) involved in the most recent (or current) capital campaign.

The Church's capital campaigns generally have not included a specific mission component. Rather, the Church has focused on the Church facility as "Mission Central," the place from which it is able to engage in mission and outreach projects. For example, the last capital campaign the Church undertook in 2012 was focused on securing funds to reduce the Mortgage balance.

Does your church have an endowment?

Yes.

What is the market value of the assets? \$904,480

<u>Are funds drawn as needed, regularly, or under certain circumstances?</u> Unrestricted income is currently distributed to the Church quarterly. Restricted income is accumulated and is distributed when requested by the Church and approved by the Church's endowment committee.

What is the percentage rate of draw (last year, compared to 5 years ago)? Distributions of unrestricted income are based on 5% of the prior 36-month average of net assets. This has been the practice since 2016. Prior to 2016, the draw was at 3%. The increase was intended to be used to help pay down the Mortgage balance.

<u>Describe draw on endowment, if any, to meet operating budget expenses for the most recent</u> <u>year and the past five years:</u> In the past 5 years, the only instance of restricted funds being distributed was during 2023, when the Church requested approximately \$10,000 from the Stephen Ministry Fund to finish the renovation on the Church's garden room, which is a room used by the Stephen Ministers' in connection with that ministry. The draw was made on interest accrued and is the only draw made in the last 5 years.

At the current rate of draw, how long might the endowment last? The intention of the Church's endowment committee has been to not touch the principal. The endowment has a conservative mix of investments with 60% equities and 40% fixed income. Based on historical market conditions, the endowment committee does not foresee any degradation of principal unless the Church were to experience a significant financial hardship.

Other Assets

Reserves (savings): Both the Church and Thrift Shop maintain cash reserves for 2 or 3 months operating expenses, so that number can vary. The Thrift Shop also maintains a capital reserve.

Investments (other than endowment): None.

Does your church have a parsonage?

No.

Describe all buildings owned by the church:

The Church's main building, it's youth ministries headquarters (the "Buoy") and other outbuildings are located at 32801 Electric Blvd., Avon, OH 44012 and can be found on the Lorain County Auditor website (www.loraincountyauditor.com/gis) as parcels 0400018115002 and 040001815009 respectively. The property was purchased in 1955.

The main building sits on approximately 2.5 acres, was dedicated in 1956 and added onto in 1961 (Education Wing; completely remodeled in 2020/2021) and 1976 (fellowship hall). In 1998, the old Sanctuary (currently, the chapel) was remodeled and, in 2006, the new Sanctuary, which is connected to the main building and where services are held today, was built. The Sanctuary had substantial preventative maintenance done in 2020 when in-person services were on hold due to the COVID-19

pandemic. The main building currently consists of (i) a front entryway and Welcome Center, (ii) Courtyard Café (coffee shop built in 2022), (iii) restrooms, (iv) fellowship hall and kitchen, (v) staff offices, (vi) Sanctuary, (vii) chapel, (viii) music room, and (ix) Education Wing. The Sanctuary can seat 400.

The Buoy, formerly a parsonage and consisting of approximately 3,600 square feet, was renovated and dedicated in 2013. The Buoy has heat and air conditioning, many large open rooms, restrooms, and storage. Attached is a large deck that overlooks the creek, a maneuverability course, and a GaGa Ball pit.

To the south of the main building is the Memorial Garden where memorial services may be officiated and ashes of loved ones are spread. Behind the Memorial Garden is approximately 11 acres of wooded, undeveloped land.

Between the Memorial Garden and Education Wing is a dedicated mulched playground area with playground equipment.

A narrow parcel of land, approximately 0.58 acres, located off of Route 83, is currently being considered for potential sale.

In addition, there are several outbuildings/garages on the property used for storage and property maintenance equipment.

Describe non-owned buildings or space used or rented by the church:

The Thrift Shop leases 2 premises within the same complex, located at 156 Lear Road and 158 Lear Road, both in Avon Lake, OH 44012. The 156 Lear Road address is approximately 1,500 square feet and is the warehouse where the Thrift Shop has storage and sells large furniture. The 158 Lear Road address is approximately 3,500 square feet and is the main store for the Thrift Shop.

Which spaces are accessible to wheelchairs? (worship space, pulpit, fellowship space, facilities, etc.)

All areas within the main building and the main floor of the Buoy are accessible.

Both premises at the Thrift Shop are accessible.

REFLECTION

After reviewing the church's finances and assets described above, what does this information reflect about your congregation's mission and ministry?

We believe our finances reflect the very nature of the Church, namely that we are a dynamic, thriving and mission-oriented church that is following our mission of Growing People to Serve God and Others through our time, talent, and treasure. A significant portion of our expenses are mission based or focused, designed to help our members, our community, and other non-profit organizations that support those in need and we actively engage with our community through the Thrift Shop.

That being said, we are no different than many churches in that we face headwinds caused by rising costs and expenses, and we have a significant financial commitment to address in the coming years with the Mortgage. However, we are confident that, as we always have, our membership, including our lay leaders, working in concert with our exceptional staff, will be creative, find and provide the

necessary resources, and deploy those resources in a fiscally sound and disciplined manner, to allow us to continue to thrive, both as a Church and as a beacon for those in the community. A few examples of this are listed below.

Our budgeting process shows a disciplined approach to managing and forecasting resources. The budgeting process begins in early October with Church Teams (led by volunteer member leaders) and staff meeting with the Business Manager to review the current year income and expenses, and to determine anticipated spending in the coming year. Once the various Team budgets are assembled, the teams review, analyze, and revise, and once final, vote to approve the requested budgets at November meetings. We budget for projected revenue from offerings, contributions and pledges by conducting a November stewardship campaign, whereby members make pledges for contributions in the upcoming year. As part of that process, we also estimate recurrent revenue from giving through automatic withdrawals in the absence of a formal pledge. That information is reviewed and analyzed by the Business Manager and Senior Minister, along with any revenue projected in the teams' budgets, to determine the most probable income amount. After all this data is collected, the chair of the Finance Team, Senior Minister, Moderator, and Business Manager work together to produce a balanced budget. That budget is reviewed, analyzed and revised, and once final, voted upon by the Finance Team in December and sent to Church Council. Church Council reviews, analyzes and revises, and once final, votes at the January Church Council meeting to submit the final budget to the Church's congregation at the Church's annual meeting in January.

Another example is how we have handled major maintenance projects that have arisen in recent years. In each of 2022 and 2023, repairs were required to our parking lot for safety reasons. Each time our Trustees (the team that leads maintenance of the Church) obtained multiple quotes for the repairs. The Trustees then worked with the Finance Team to find ways to pay for the expenses within the existing budget, showing our ability to handle unexpected challenges in a disciplined and creative manner.

Finally, the Thrift Shop serves as a shining example of what our Church can do. In 2019, Church Council agreed to move the location of the Thrift Shop from its then existing location to its current premises. Not only did the Thrift Shop survive the COVID-19 pandemic and the move, it thrived, doubling revenue to approximately \$500,000 in 2023, compared to approximately \$252,000 in 2019. Led by an innovative and determined team of staff and volunteers, the Thrift Shop provides a meaningful service to the community while also contributing over \$190,000 to mission gifts in 2023.

3f. HISTORICAL INFORMATION

Name one to three significant happenings in the history of your church that have shaped the identity of your congregation. Add the most important event in the life of your church in the past 10 years.

Describe a specific change your church has managed in the recent past.

The COVID-19 pandemic was a significant event in the history of Avon Lake UCC, and while COVID impacted churches across the world, it affected each in different ways. Avon Lake UCC was quickly able to pivot to virtual services through Facebook live. For years, Avon Lake UCC has maintained a high level of proficiency in the use of technology having also broadcast live services on local cable

television. This positioned the Church well for being able to reach viewers across the country during the pandemic. While Avon Lake UCC conducts in-person services today, it is still able to reach viewers across the country, and occasionally internationally, through its virtual service offerings. The pandemic also provided an opportunity for the Church to make needed repairs and renovations to the property. Among the more significant property improvement activities included the engagement of contractors and volunteers to repaint the Sanctuary, the addition of blinds to control sunlight in the Sanctuary, and a major renovation of the Education Wing, restrooms, and Sunday school rooms. The church was very forward looking in using the opportunity of less foot traffic in the Church because of the pandemic, to accomplish a number of needed projects.

Within the past several years, Avon Lake UCC made the difficult decision to close its Jack-n-Jill daycare/preschool ministry. Jack-n-Jill was a part-time preschool with enrollments declining over the years as a result of competition from full-time preschool providers. As good stewards of Church resources, it was simply unsustainable to maintain the preschool. Although a difficult decision, it affirms the fact that under the leadership of the Senior Minister, Avon Lake UCC routinely evaluates its ministry and stewardship on behalf of the congregation.

Within the past several years, a somewhat controversial decision was made to expand the Church's Good Neighbor Thrift Shop operation by moving it to a new location and incurring additional lease costs for the new space. The expansion also necessitated some operational changes to realign Thrift Shop management and finances with the Church's general finances (see full description under section 3a. Church Finances earlier in this Profile Document). Despite the fact that the new location was literally within a few hundred feet of the old location, some members were concerned about the additional cost to utilize the new space. The new space afforded a considerable advantage over the previous space including additional square footage and a sizable intake area for receiving and inventorying donations. Others believed that the Church should use the opportunity to acquire or lease even larger space in a different location. However, the decision to relocate the Thrift Shop in the same vicinity allowed it to service the constituency it had already been serving for years. The move has proven to be a successful one in that the Thrift Shop has considerably surpassed all expectations of revenues from the time of the relocation, with over 50% of the revenues being donated directly to mission projects, agencies, and organizations.



Another significant event in the recent history of Avon Lake UCC involved a change within the Church's music ministry. Church members enjoy a traditional music worship experience during its early Sunday worship service, and a more contemporary music worship experience during its later morning service. Music is an integral part of any worship experience, and Avon Lake UCC has created a music worship experience that appeals to its wide constituency from youth to its senior members. However, based on feedback from the congregation, Church leadership was challenged to find a way to re-evaluate and create a more cohesive and engaging music ministry. Avon Lake UCC used the time created by the COVID-19 pandemic to re-vision its music. As a result, Avon Lake UCC hired a new Director of Music Ministries to ensure that each service continued to maintain its individual music identity, consolidated under a leader talented to toggle between both. The results of this revisioning have been widely celebrated.

The most important event in the life of Avon Lake UCC in the past 10 years is the impending retirement of the Senior Minister. The Rev. Dr. Kelly Brill has been the Senior Minister of the Church since 1995 and is well loved by the congregation. As part of the process regarding Dr. Brill's retirement, the congregation was surveyed to gauge individual views about the Church and its direction moving forward. There were many reflections praising Rev. Dr. Brill's work over the years. While the Church appreciates Dr. Brill's years of service and recognizes that a change is inevitable, any replacement will represent a considerable adjustment for the congregation. Consequently, considerable effort is going into easing that transition, in part through a campaign reflecting on change and growth in the Church over the years, with a focus on the congregation as the heart of the Church.

Every church has conflict, some minor, some larger. "Where two or three are gathered, there will be disagreement...". Describe your congregation's values and practices when it comes to conflict.

The congregation is in a relatively affluent area and is not racially diverse. During the height of the COVID-19 pandemic, around the time George Floyd was murdered, there were tensions in the congregation related to social justice. There were those in the congregation who felt that the Church should exercise a larger voice around the issues of racial inequality, while others believed that the Church should remain "neutral". There were also political tensions surrounding the 2020 election, as the congregation is politically diverse.

While the congregation is extremely welcoming and advances the causes of many organizations through its mission work, there were congregational disagreements about the Church's role in being a public voice for issues about which there were many opinions and emotions, to avoid the appearance of taking sides, and to minimize internal conflict. Under the collaborative leadership of both clergy and laity, the Church was able to address the issues of fairness, equality, social justice, and respect for differing opinions in a way that balanced the varied congregational perspectives. The Church has navigated challenging circumstances with love, compassion, and acceptance which is indicative of the congregation's respect for the Senior Minister's leadership in working through difficult circumstances.

4a. COMMUNITY VISION

How do the relationships and activities of your congregation extend outward in service and advocacy?

The Avon Lake UCC actively engages in service that provides immediate impact to individuals and communities and demonstrates our congregation's focus on social justice issues.

Our Church has been actively engaged in refugee resettlement efforts in recent years, supporting families from Afghanistan and from Ukraine. At least two dozen Avon Lake UCC members were directly involved in helping these families — bringing meals, providing transportation, familiarizing with communities, playing with children, etc.

We have a close connection with St. Paul's UCC, a "sister church" in an urban neighborhood of Cleveland — one of our members serves on their outreach board, one of our staff members helps them regularly with technology needs, our Senior Minister serves as a mentor to their pastor, etc. From time to time, we have engaged more deeply with that community (i.e. members of their church participating in our fellowship activities).

Several members of our church are active on boards and as volunteers with several of our mission partners. We have actively pursued educational opportunities to learn more about issues such as homelessness and addiction.

The Mission Team coordinates with a large number of community outreach and agency support activities (15-20 in total). Examples include:

Spring and Fall Food Drives, with the proceeds being shared among multiple agencies.

Christmas Giving Tree, with gifts purchased by the congregation and shared among multiple agencies.

Doorstep Dinners — the delivery of meals to congregants experiencing difficult times.

Haven Center Monthly Dinners — the preparation of a meal by congregants for those staying at the Haven Center which is a shelter for families experiencing homelessness.

Collection of personal hygiene items for individuals who are homeless and seeking services delivered by St. Paul's UCC.

Services to others is at the core of the Youth Program at Avon Lake UCC. The program conducts and coordinates a number of activities that benefit communities near and far. Examples include:

For the past 15 years, the middle school and high school groups have participated in week-long service trips across the country.

The Junior High Youth Group supports a summer mission program at Washington United Church of Christ in Cincinnati. Ohio.

The Senior High Youth Group travels to different locations to engage in home rehabilitation or disaster relief, partnering with a number of organizations and agencies.

Over the course of the year, the youth have opportunities to serve, learn, and grow ranging from sorting donations at our local food bank to raking leaves for those unable, to volunteering with organizations like Youth Challenge and assisting with mission opportunities provided by the Church.

Through Avon Lake UCC's Good Neighbor Thrift Shop (in continuous operation and service for the past 44 years) our Church:

Provides annual grants to partner agencies and organizations within Lorain County and beyond. In 2023, we distributed over \$167,000 to 15 agencies in response to community needs. Our total annual Mission giving exceeded \$278,000 when adding in budgeted donations, compared to \$156,000 in 2022.

Provides monthly in-kind donations of furniture and baby items to the Neighborhood Achievement Hub, which serves the largely immigrant and vulnerable populations on Cleveland's west side.

Gives the refugee families supported by Avon Lake UCC and other local churches the opportunity to "shop" the store for free.

Provides residents of the Road to Hope & Primary Purpose sober living facilities regular opportunities to participate in work projects and shop for free.

Collects and distributes clothing and other necessities to agencies working with the unhoused. We partner with the Community West Foundation to be the designated drop off location for the Socks+ program in Lorain County.

Partners with an area recycling company to process unsold donations to help eliminate the number of items that might end up in the landfill.

Responds with gifts of clothing and housewares to families/individuals in our community (and schools) who have suffered loss and/or crisis.

Provides funding and service opportunities for our youth groups as they grow within our Church.

Describe your congregation's participation in meetings, relationships and activities connecting the wider United Church of Christ (association / conference / national setting).

Avon Lake UCC maintains its connection to the wider church in various ways. It is part of our "branding," and we link to the wider church on our website.

Given our geographical proximity, at various times we have had members of our congregation who worked in the national office (most prominently John and Mimi Dorhauer). Tim Harris is a member of our Search Committee and former Moderator of the congregation; he is President and CEO of the Insurance Board.

Our current Senior Minister has been active in the Association and Conference in various capacities as have laypersons. Both of our current ministers and our Director of Youth Ministries participate in clergy excellence groups/communities of practice through the Association.

We regularly send delegates to the association and conference meetings, and we occasionally have had delegates to the General Synod from our congregation.

We maintain an extremely close tie with the summer camping/outdoor ministries program of our conference, an effort that is enthusiastically pursued by our Director of Youth Ministries. Most (if not all) years, we send more youth and adults to camp than any other congregation.

We have always supported OCWM, funded through our Good Neighbor Thrift Shop and various other special offerings.

Many local churches love to tell the story of what they are doing in the community to transform lives. Avon Lake UCC has participated in many of the above-listed efforts, without pursuing the official designations. We have a robust outreach to and with those who are living with mental illness and their loved ones, for example, including a monthly support group, occasional special speakers, special Sundays, etc. We have had close relationships with global mission partners over the years. We are very cognizant of accessibility issues every time we pursue a building improvement project or new construction.

People are often drawn to Avon Lake UCC because of how our Beliefs and Welcome are stated on our website https://avonlakeucc.org/ as shown below:

What We Believe: We believe in taking the Bible seriously, but not literally. We engage in Bible Study, discussing together what the texts meant originally and their relevance to our lives today.

Welcome Statement: We, the Avon Lake United Church of Christ, strive to be people of extravagant welcome. We affirm that all people are created in the image of God, and we celebrate the diversity of God's creation.

As we seek to become faithful disciples of Jesus Christ and endeavor to live out our shared mission – Growing People to Serve God and Others – we respect and gladly receive persons of every race, ethnicity, nationality, gender, gender identity and expression, sexual orientation, mental and physical ability, age, socioeconomic status, marital standing and family structure, and religious background.

We believe that our political differences can be a source of strength, as together we practice civil discourse.

We welcome those who are seekers, those who aren't sure what they believe, all who come in a spirit of openness and mutual respect.

We affirm that the Holy Spirit gathers us as a congregation in which all persons are invited to participate in the life, leadership, ministry, fellowship, worship, sacraments, responsibilities, blessings, concerns,

and joys of our community of faith. We hope and pray that by establishing and embodying this covenant of inclusion, we might fully follow Christ's commandment to love God and neighbor and be a safe place where love abounds.

Describe your congregation's participation in ecumenical and interfaith activities (with other denominations and religious groups, local and regional).

In prior years, there was an Avon Lake Ministerial Association; clergy would meet monthly and would plan ecumenical worship services together. Unfortunately, that group disbanded many years ago. There are no other ongoing groups of which we are aware, but it is fair to say that our congregation would be very supportive of such activities. We had a relationship with a group of Muslims from Turkey for a while and offered many opportunities for our two communities to come together for learning and community-building. We have been involved in refugee resettlement. Our Confirmation class regularly visits a mosque, a synagogue, and other houses of worship. There is a definite openness to ecumenism and interfaith relationships.

If your congregation has a mission statement, how does that mission statement compare to the actual time spent engaging in different activities? Think of the range of activities from time spent gathering, to governance, to time spent going out.

Avon Lake UCC's Mission Statement: Growing People to Serve God and Others

There is a strong focus on personal growth in fellowship in the Avon Lake UCC. Cross Training is a multi-week opportunity for worship and learning that is held twice yearly. Each week begins with a worship service, after which attendees break out into their selected area of focus. The areas of focus are diverse, with recent topics including studying the book "The Universal Christ" by Richard Rohr, and "CAN WE TALK? Civil Discourse in Our Polarized World?" among others. Bible study has been held in different forms continuously over the years. The programming for youth from Sunday School to groups for various ages through high school offers fellowship, learning, and growth. In addition, there are numerous events, exercise classes, group outings, and a fall fest, that serve to bring the congregation together for fellowship and growth outside of the traditional church setting.

Service to others is a hallmark of Avon Lake UCC, an aspect to which many members are deeply committed. It begins locally, with the Good Neighbor Thrift Shop, that offers clothing and household goods, including furniture, electronics, and small appliances at very affordable prices. It extends to the wider region through financial assistance to service organizations. It extends further through the youth program which supports two mission trips each year, with the Junior High Youth Group providing a week of support at a childcare center in Cincinnati, and the Senior High Youth Group providing a week of service at varied locations, typically outside of Ohio. A significant number of adults participate in the trips, supporting the youth and contributing to the effort. Many youth speak of these trips as being foundational to the manner in which they view the world and evolutionary in terms of how they view themselves

Reflect on the scope of work assigned to your pastor(s). How is their community ministry and their ministry in and on behalf of the wider church accounted for in the congregation's expectations on their time?

The Senior and Associate Ministers delegate effectively to highly capable staff and volunteers who are empowered to act on behalf of the local Church and our mission activities beyond our congregation,

giving the Ministers adequate time to extend their ministries into the wider church in ways that they feel have the most impact. The Senior and Associate Ministers are expected to be available for counsel, planning, problem-solving, and connection to the overall mission of the Church. The Ministers act as "Keepers of the Vision," and are not expected to participate in every mission event, activity, or program that our Church supports in its wider mission outside our congregation. Our staff and volunteers are exceptionally dedicated to the wider mission and our many mission partners, freeing the Senior and Associate Ministers to concentrate on worship planning and preparation, personal visitations, group Bible and book studies, and the activities most meaningful to them.

4b. MISSION InSite

Comment on your congregation's Mission Insite report with data for your neighborhood(s) or area. What trends and opportunities are shown?

Because of the homogeneous demographics of the city of Avon Lake, Avon Lake UCC extends its ministry reach into the surrounding and less affluent communities of Lorain County, as well as into inner city Cleveland (Cuyahoga County). Several of the Mission Partners who are supported by the Good Neighbor Thrift Shop are in the communities in and surrounding Elyria, Lorain, Sheffield, and Amherst. We provide significant financial and leadership support to these organizations, through financial gifts and through volunteer efforts, including participation on the boards of some of our Mission Partners. We expect that needs in our outlying communities will continue to grow at a moderate pace, as the population grows, over the next 5-10 years. Depending upon economic circumstances and the demands on human services in those areas, Avon Lake UCC may have a growing opportunity to increase the scope of its ministries.

How do your congregation's internal demographics compare or contrast to a) the neighborhoods adjacent to your church, and b) other neighborhoods with which your church connects?

Avon Lake is in Lorain County, Ohio, on Lake Erie between two relatively large populations, Lorain/Elyria (10 miles) and Cleveland (24 miles) with suburbs extending between Avon Lake and these population centers. It is in the northeast corner of Lorain County, adjacent to Cuyahoga County.

Avon Lake experienced rapid population growth during 2000-2010, with the population in 2023 standing at 25,588. It is expected to grow moderately in the future. Avon, to Avon Lake's south, also will experience moderate growth, while the other adjacent communities' populations are expected to stay the same or modestly decline.

The level of adult education is very high in Avon Lake, Bay Village (the city to the east), Avon, and Westlake (the city to the southeast). Adult education levels are mixed in Sheffield Lake, the city to the west.

The populations of Avon Lake, Avon, Bay Village, and Sheffield Lake are all very homogeneous, with most of the population being white (non-Hispanic). Generally, to the east and west, as one approaches the larger population centers, the level of racial and ethnic diversity increases.

Avon Lake's median family income is significantly higher than the state average, as is the case with the adjacent communities, apart from Sheffield Lake, which is close to the state average. The level of poverty follows the same pattern, with Avon Lake and adjacent cities being significantly below the state average, apart from Sheffield Lake's level of poverty being somewhat below the state average.

The workforce in Avon Lake is closely split between blue-collar and white-collar, and the same is true of Sheffield Lake, with Avon, Bay Village, and Westlake leaning somewhat towards a white-collar workforce. There is a large Ford plant that occupies portions of Avon Lake, Sheffield Lake, and the Village of Sheffield that employs many people and provides significant tax revenue. There is other industry located near the borders of Avon Lake, Sheffield Lake, and the Village of Sheffield, and the southwestern area of Avon Lake has some light industry and warehouse facilities. Otherwise, aside from a small amount of retail, Avon Lake mostly consists of residential neighborhoods.

The city of Avon Lake has a varied population in terms of age. The average age is 43 and that is not projected to change in the next 10 years, although the number of people 65 and over is expected to grow by 5% during that time. 19% of the population is under the age of 18.

How are the demographics of the community currently shaping ministry, or not?

The demographics very much shape the ministry of Avon Lake UCC. Warm welcoming of visitors and new members and embracing diversity in all forms are hallmarks of the congregation and ministry. This has led to an increase in membership of people who might not feel as welcome in other congregations, and who might otherwise choose to not join any congregation. The youth ministry is very strong and draws people to the Church and engages teenagers in Church activities. Despite the overall generally positive economic numbers for the immediate area, and despite the seeming racial homogeneity in the immediate region, there are significant populations, in and near the major population centers, where poverty and homelessness are serious problems for people of all races and ethnicities. Drug and alcohol abuse are pervasive problems in all the communities in the region. Avon Lake UCC contributes significant time and treasure to directly assist individuals and families, and to support organizations focused on these social challenges. Those activities range from opening the Church to AA groups, to individuals and groups within the Church contributing their time and talent to a variety of causes, and to direct financial support for individuals and organizations. Through a grant process, non-profit organizations can submit applications enabling the Church to identify and contribute to those organizations that are best positioned to provide support for the community.

Although some modest growth in population is expected over time, in most regards the city of Avon Lake and the surrounding communities are likely to remain similar in terms of social and economic demographics for the foreseeable future. The opportunities in the future, and challenges, will probably be like what the Church experiences today. That's good news in the sense that the Church can examine what is presently working well, and the opportunities that exist today, and deepen our engagement with our community with confidence these steps will be appropriate to serve the community and region both in the present and into the future.

What do you hear when you talk to community leaders and ask them what your church is known for?

"During the [2023 Avon Lake mayoral election] campaign there were times when the subject of church, volunteerism, and mission would come up. As the conversation turned to what church I was with, I would always get positive feedback when I responded with 'Avon Lake UCC, the church across from Bleser Park!' Some were aware of our relationship with the Good Neighbor Thrift Shop. They would comment on what a 'wonderful' and 'friendly place' it is and how it is amazing how so much money gets donated to others. Others commented on 'all the wonderful assistance' the Thrift Shop provides to so many. Regarding the Church, comments such as 'I've heard about all the amazing things the Church does' and 'My kids go to the youth groups and they love it!' The youth programming and mission trips have been brought up, often because I frequently brag about it! 'I can't believe you take so many young people all over the country to do this work – amazing.' 'God bless everyone who is involved in

these trips.' Additionally, others are surprised by the size and activeness of our Church, wondering 'How do you have so many people involved?'" (Mark Spaetzel, Mayor, Avon Lake, OH)

Past mayor Greg Zilka has lived in Avon Lake since 1974 and said he has always been impressed with Avon Lake UCC. His impression is that it's a social leader, setting the tone in Avon Lake, with members representing the community on the school board and in city council. He feels it is highly respected, and that there is good collaboration with other churches to make Avon Lake a great place. (Then current mayor Greg Zilka was interviewed by John Rice, member of the Search Committee, in December, 2023)

"Avon Lake UCC is known for being welcoming to all, very mission-focused, and for having a great youth program that is active in mission trips. I think people know Avon Lake UCC for its annual Cornhole Tournament that is a big fundraiser and brings in a lot of outside community members." (Jim Stobe, President, Avon lake Board of Education)

"I have deep appreciation for Avon Lake UCC's focus on inclusion, its welcoming of all people without bounds. In particular, I appreciate how the Church speaks to and acts toward stress and anxiety, its acknowledgement of the importance of mental health, and its combating of stigma by embracing all aspects of the human experience." (John Rice, President of the Board, National Alliance on Mental Illness, Greater Cleveland)

What do new people in the church say when asked what got them involved?

"The glowing endorsement of Avon Lake UCC submitted by our neighbors initiated our interest. Oftentimes members are not vocal or disciplined about recruitment and that personal "ask" is critical. Once we were in the door, the welcoming attitude shared by EVERYONE was so important to us. The Church feels healthy with a nice mix of age groups." (Mike – Joined 2023)

"When we attend a service, I feel like it's been planned just for me! Whether it's a song, a prayer, or a reading, there is a message for me that touches my heart. And the sermons touch my heart as well...it's like they're speaking just to me. I'm impressed with the opportunities to serve and become involved at Avon Lake UCC. I look forward to finding my niche!" (Tracy – Joined 2023)

"What got us involved at Avon Lake UCC was the immediate feeling of a caring community when we first walked in the door. We could feel it, and it felt familiar to us, and it is what we were looking for (along with a contemporary service with great music). Each week, it really is impactful for me to hear the pastors say: 'Please let us know if there is anything that the Church can do for you.' We were also looking for a church that was open and welcoming, while also being a middle of the road church. Avon Lake UCC fits well with that, and the groups that we have participated in emulate that." (Tom – Joined 2020)

"My husband had researched churches online in the Avon Lake area and we visited a few, including Avon Lake UCC. We found a totally accepting climate, comfortable and beautiful setting, close to home, with up front friendly people who actually take action with many and varied mission partners. That action, accepting component, and a kind, smart pastor was important to me. A pastor who will actually speak about national and world issues without taking sides and letting me decide my place is also a very important quality of Avon Lake UCC." (Nancy – Joined 2019)
