The real work of implementing that plan has begun, and will serve as a key guidepost for an Interim Minister and for the settled Senior Minister search. The recommendations from the Strategic Planning Task force center on a delivery focus of staff and volunteer resources on community formation and maintenance, engaging members and newcomers in community(ies) within the church:

- Do better at welcoming: encountering, engaging and maintaining our community in worship, caregiving and fellowship.
- Promote intergenerational opportunities through programs.
- Promote volunteer-focused activities to raise awareness and increase engagement.
- Encourage strategic decisions and investments to enhance the value of the building to the broader community.
- Focus on "soft entry" events to draw the community in, to become familiar with and comfortable with the church

* Developed and communicated a comprehensive Strategic Plan that looks forward to the shape of ACC and its staff, programs, etc. Work on implementing this plan has just begun and will be a tremendous guidepost for an interim minister and settled senior minister.

ACC's engagement is both local and global. Through our volunteer-run Cornerstone Thrift Shop we offer an economical shopping experience, generating income the church can return as contributions to other service organizations. Our Missions and Outreach committee draws on ACC member pledges to contribute to nonprofits that are local, regional, and international in impact.

The church has a volunteer connection with a number of service organizations as well, including the Acton Community Supper, Household Goods Recycling, the Acton Food Pantry, Lazarus House, Habitat for Humanity, and RISE Against Hunger. An annual Christmas tradition, the ACC Mitten Tree, offers the opportunity to give generously to families and seniors in need. In addition, our annual youth mission trip is a hands-on, tangible service to a community in need, in addition to providing a valuable experience. Each year we donate Thanksgiving baskets to our sister church, Jamaica Plain's Iglesia Hispana de la Comunidad.
